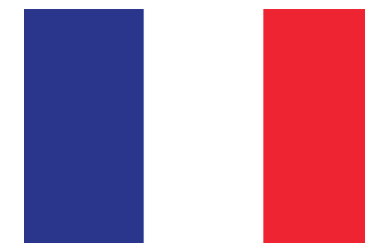


Development partner (DP) visual aid: FRANCE

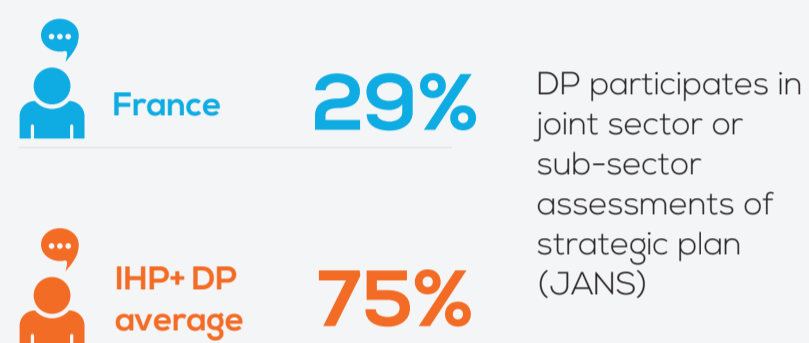

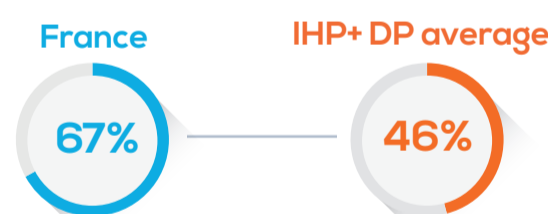

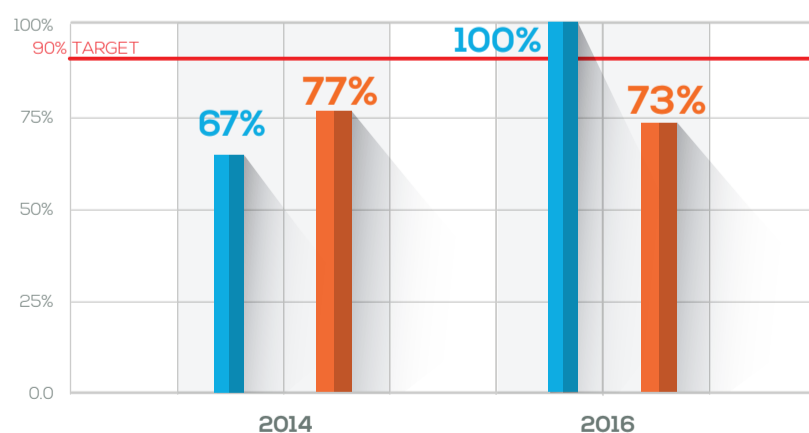

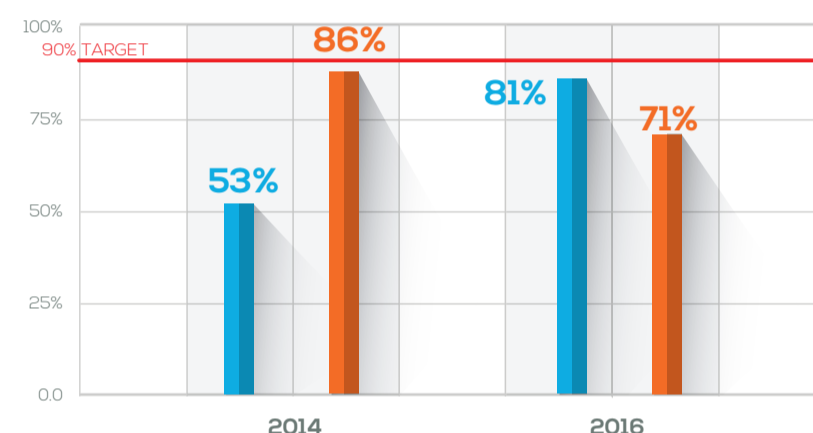

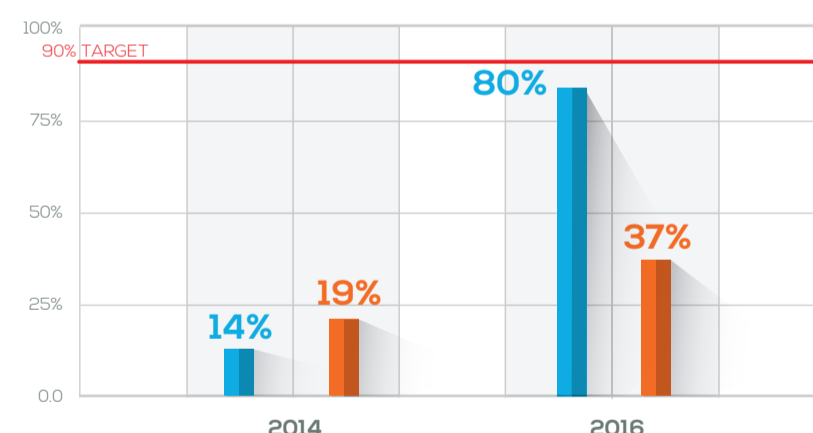
TO IMPROVE THE FINANCING, PREDICTABILITY AND FINANCIAL MANAGEMENT OF THE HEALTH SECTOR

DP funds disbursed to the government according to agreed timelines.

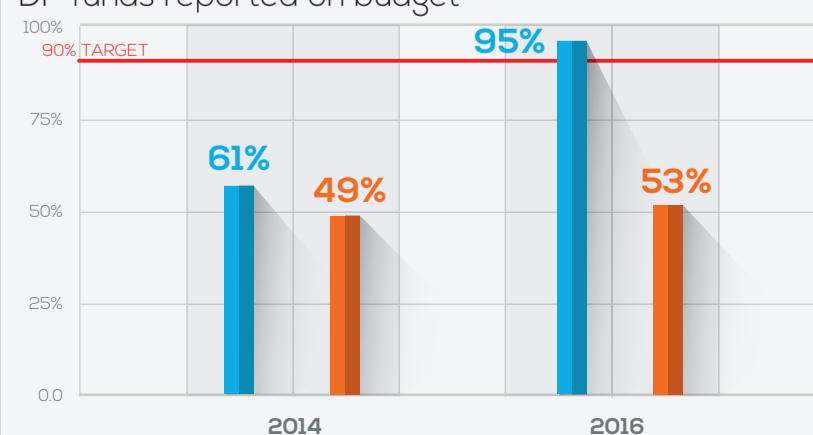


Predictability of funds for future - DP has communicated forward looking expenditure for 3 years ahead to government

DP funds reported on budget

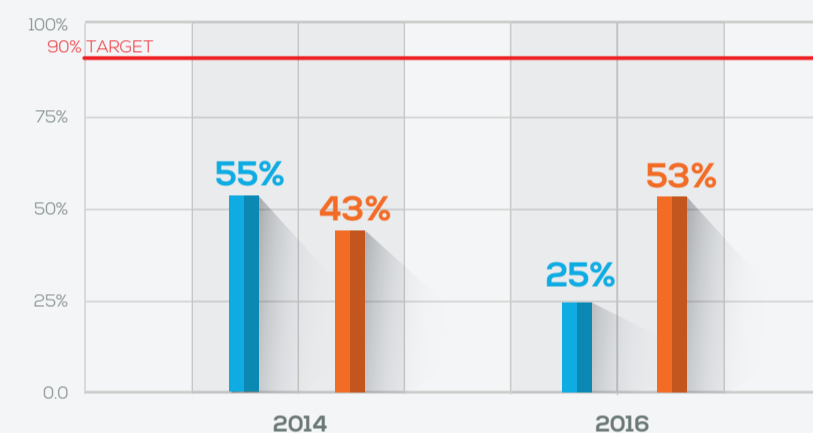

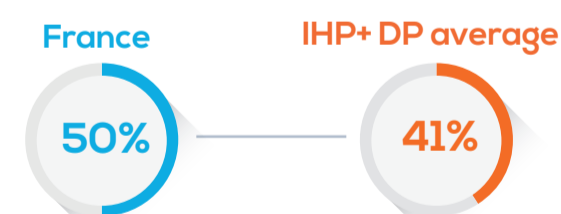
PUBLIC FINANCIAL MANAGEMENT (PFM) SYSTEMS ARE STRENGTHENED AND USED

DP funds use national expenditure procedures. Note: data provided only for countries with CPIA 3.5 or higher.



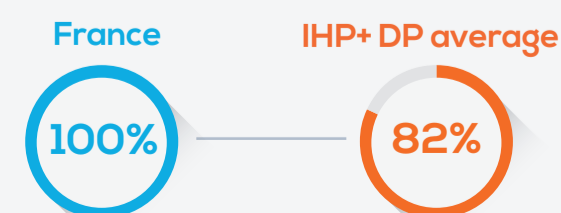
PROCUREMENT AND SUPPLY SYSTEMS ARE STRENGTHENED AND USED

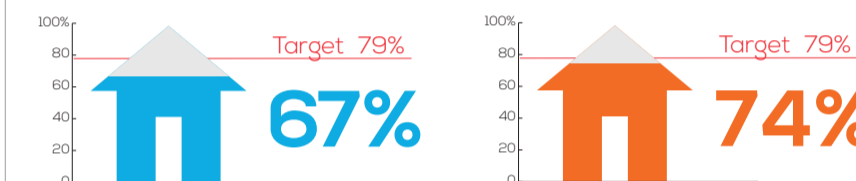

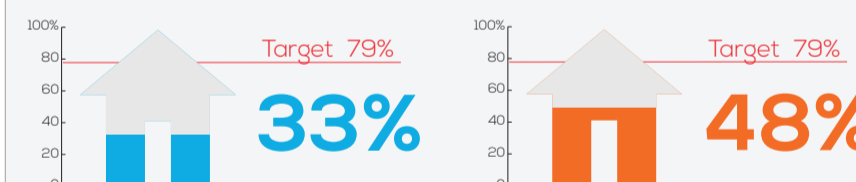
CIVIL SOCIETY ORGANISATIONS ENGAGEMENT

DP supports private sector organisations (Support can include financing or technical support)

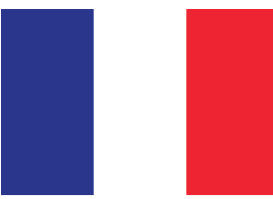


HOW TO READ THE PERFORMANCE PROFILE

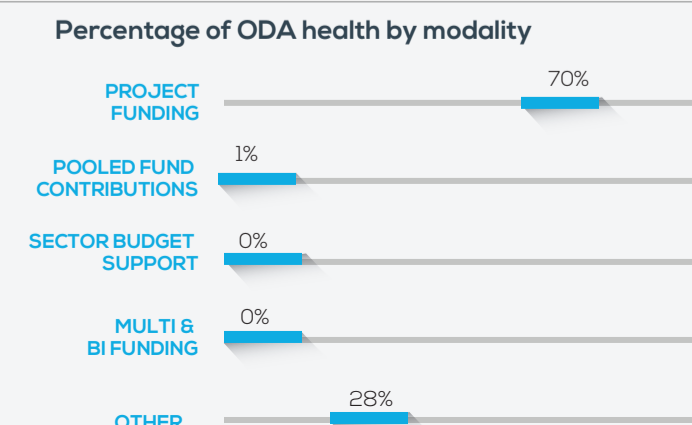
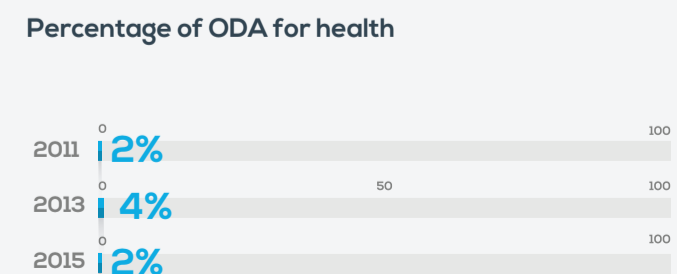
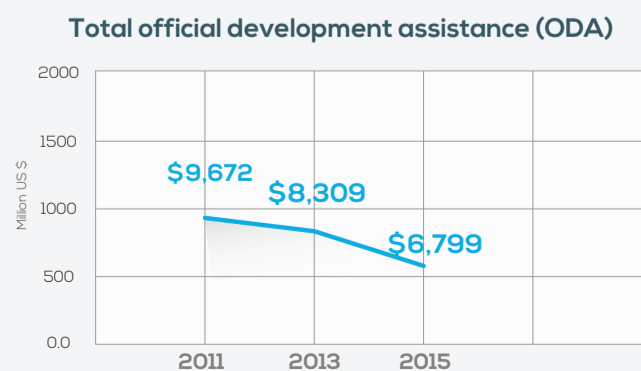
