

# Development partner (DP) visual aid: NETHERLANDS

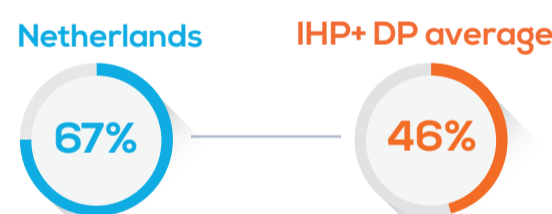

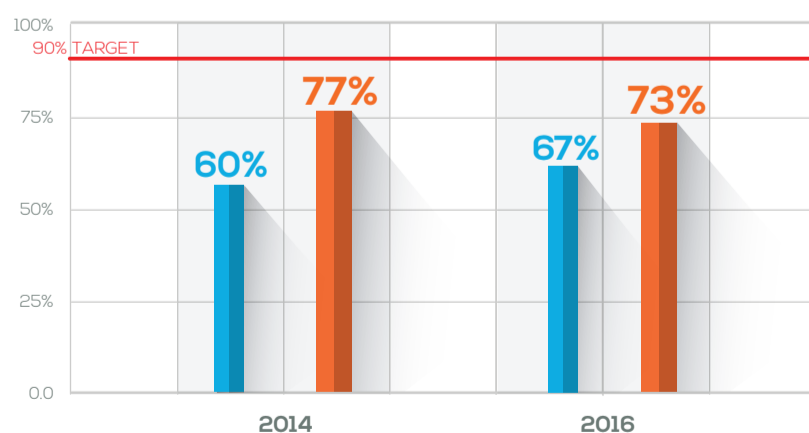

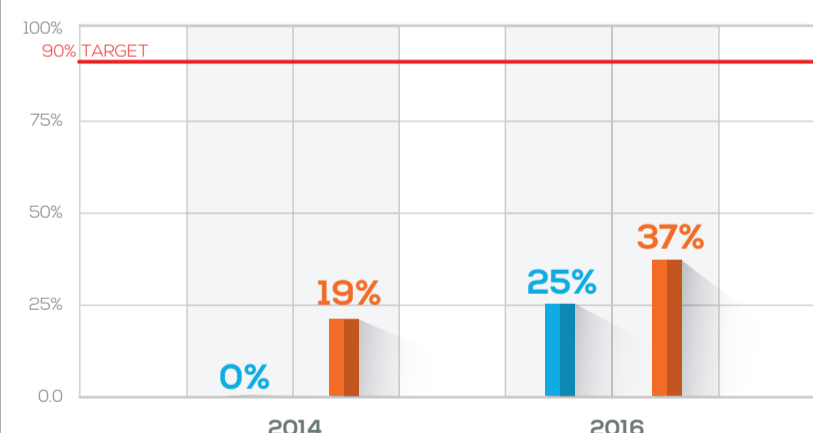
TO IMPROVE THE FINANCING, PREDICTABILITY AND FINANCIAL MANAGEMENT OF THE HEALTH SECTOR

DP funds disbursed to the government according to agreed timelines.

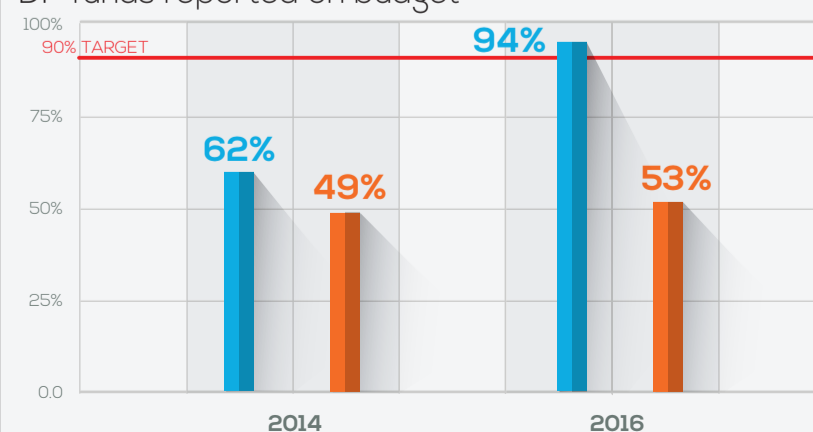


Predictability of funds for future - DP has communicated forward looking expenditure for 3 years ahead to government

DP funds reported on budget

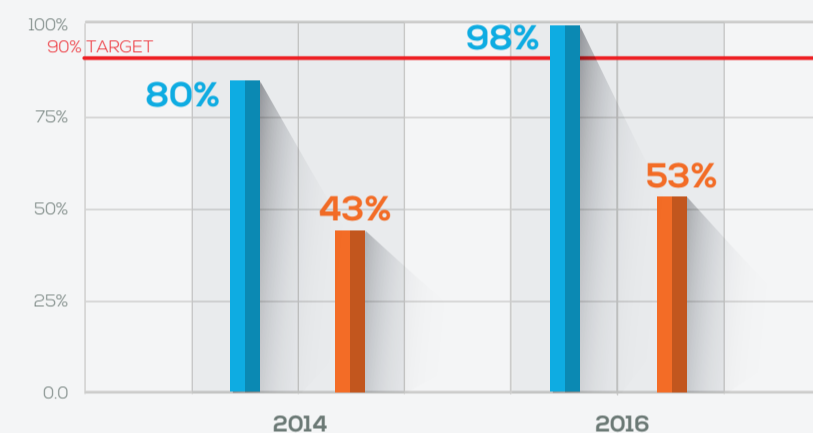

TO ESTABLISH, STRENGTHEN AND USE COUNTRY SYSTEMS

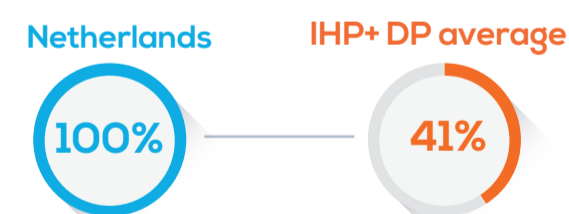
### PUBLIC FINANCIAL MANAGEMENT (PFM) SYSTEMS ARE STRENGTHENED AND USED

DP funds use national expenditure procedures. Note: data provided only for countries with CPIA 3.5 or higher.



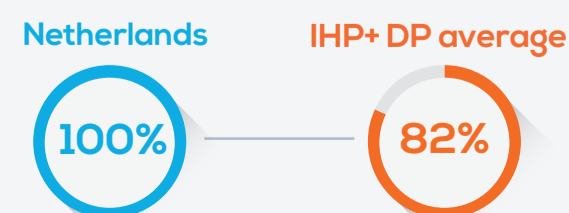
### PROCUREMENT AND SUPPLY SYSTEMS ARE STRENGTHENED AND USED

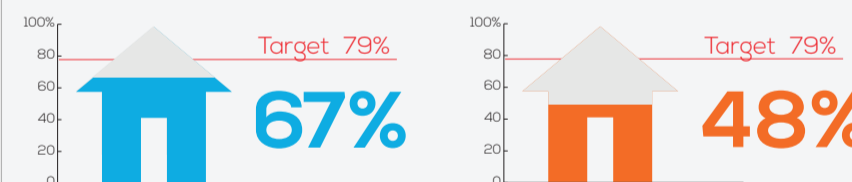
### CIVIL SOCIETY ORGANISATIONS ENGAGEMENT

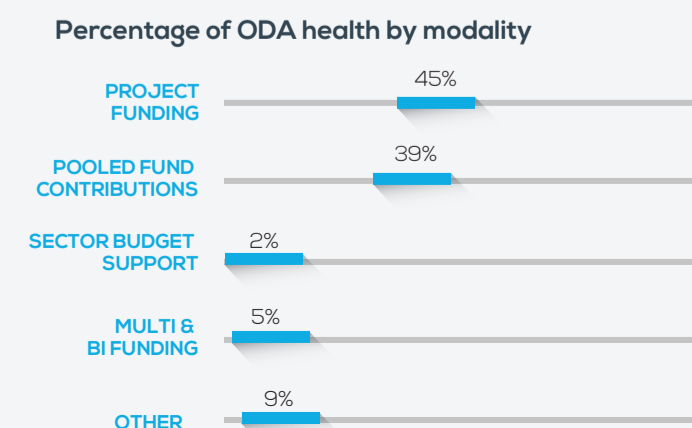
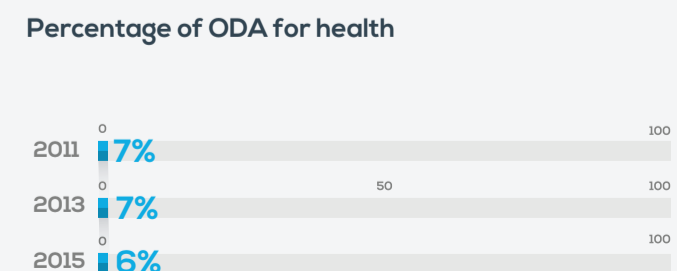
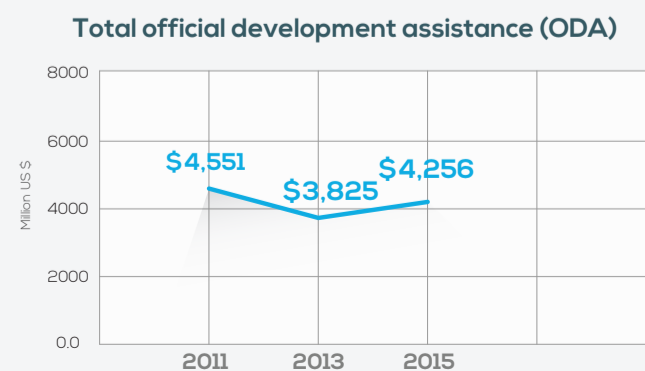
